Who Can Apply:



Residents

- Be a City of Waterville resident
- Be current on all local, state, and federal taxes or assessments
- Applied to FEMA
- Have a provable loss including but not limited to: loss of structure, loss of residential contents.
- Have a loss not covered completely by insurance
- Have a need that is not covered by insurance, cash, or FEMA



Businesses

- Own a business or commercial property in the City of Waterville
- Be current on all local, state, and federal taxes or assessments
- Be categorized as a small business according to the Small Business Association (SBA)'s guidelines of "small" meaning those with less than 500 employees or \$15 million in receipts, with specific guidelines for certain industries
- Be located in an industrial, commercial, or retail storefront.
- Have a provable loss including, but not limited to: loss of inventory, structure, or business infrastructure
- Have a loss NOT covered completely by insurance
- Not have enough "cash on hand" to make up losses
- Applied to SBA

Applications

Complete the short application form. There is a residential application and a business application. Complete the appropriate sections and attach the required materials such as FEMA (for residential application) and SBA Disaster Loan information (for business application), insurance claims, etc. We have attempted to streamline this process as much as possible to make it easier on applicants by asking for the documents you have already filled out for other agencies. This allows the committee to keep the application process simple yet will provide transparency and will give the grant committee the information they need to determine who needs the assistance the very most.

An application review committee will start reviewing application in August 2024. Applications will be reviewed and awarded monthly until the fund is depleted. Awards will be made to applicants who present the direct human and financial need.

- . Residential applicants are eligible for grants of up to \$500
 - Business applicants are eligible for grants of up to \$1,000

*Applications will be reviewed on a case-by-case basis. Approval is at the discretion of the committee.
